## **European Banking Overseas**



This volume contains the papers presented at the colloquium "European Banking Overseas 19th – 20th Century". This colloquium of the *European Association for Banking and Financial History (EABH) e.V.* took place in Amsterdam in June 1999.

The seven parts of this volume reflect the seven subthemes into which the colloquium was divided. Traditionally the first part deals with the history of the celebrating host of the conference, *ABN ANMRO Bank*. Part 2 to 7 discuss different aspects of European overseas banking; some of the papers also examine the current stat of affairs and possible future developments. As economists, historians as well as archivists are associated with the *EABH*, their

respective fields or interests are represented in this volume.

## The Editors

**Ton de Graaf**, born 1955, is corporate historian of ABN AMRO Bank and Heas of ABN AMRO Corporate Archives, Amsterdam. He studied History at the University of Amsterdam. In 1991 he became corporate historian of ABN AMRO Bank. Ton de Graf is publishing in the field of banking and regional history. His most recent publication amon others was in 2006 *Leven in Blankenham: een Overijsselse plattelandsgemeenschap in het tijdvak 19650-1850.* 

**Joost Jonker** is Associate Professor at Utrecht University. His research focuses on business and finance from the 16th century to the present. His main interest is the interaction between firms, markets, and business leaders during any given period. His publications range from short biographies of Dutch businessmen, or a co-written monograph on international trading companies to an analysis of the 19th century Amsterdam money market. He also co-authored the recent comprehensive history of Royal Dutch Shell and is currently working on the evolution of financial markets in pre-industrial Europe. His latest publications are From Challenger to Industry Leader, 1890-1939, a History of Royal Dutch Shell Vol. 1, in cooperation with J.L. van Zanden in 2007, and Größe um jeden Preis, der Aufstieg und der vorhersehbare Fall von ABN AMRO 1960-2006, Geld und Kapital, Jahrbuch der Gesellschaft für mitteleuropäische Bankenund Sparkassengeschichte in 2007/2008 (pp. 175-198).

**Jaap-Jan Mobron** is a historian at ABN AMRO Historical Archives, Amsterdam. He has studied medieval history, modern history, archiving and history of International Relations. His main scientific interests are banking history; banking architecture and colonial architecture. Before his position at ABN Amro he worked for Rabobank and Nederlands Scheepvaartmuseum Amsterdam **and also** used to be a freelance reporter. *Furthermore*, he has been project manager for a variety of publications. His latest work was published in cooperation with B. Slot *Eendracht maakt macht: beleggingsfondsen van ABN AMRO en voorgangers*, 1774-2007 in 2008.
